6. Executive Director's Report – Kelly Dunham

# Finance Oversight Team Update – Kelly Dunham

### a. Quarterly Agreed Upon Procedure Update

Kelly reported that the FOT's recommendation is that we continue to do the procedural audits with our current auditing firm (Rehmann) and that we have been able to negotiate with them on the expense of these audits. The firm will revise their proposal to perform procedural audits throughout the year for the Board to consider in April.

#### b. Land Acquisition Financing

The FOT recommends the establishment of a land acquisition capital funding account. After reviewing our overall cash position and funding levels of our reserve accounts, the recommendation is to fund the acquisition without any borrowing. Director Rushton asked if these would be restricted funds. Although these will be restricted funds, the decision to do so is local, and in the case of future need, restriction could be lifted upon board approval. The board would like to see the funds currently labeled as restricted to be restated in more general terms.

A budget for the use of the designated funds will be presented to the Board prior to any expenditures of such.
